

Affinity Water: Indicative Primary Wholesale Access Charges & Statement of Assurance 2019/20





1. Schedule of Charges

- (1) The Schedules of Indicative Primary Wholesale Charges for 2019/20 are set out in the following pages of this document
- (2) The purpose of publication is to provide a transparent indication of primary wholesale charges to existing and prospective retailers to support effective markets
- (3) Wholesale charges form the basis of charges to retailers for wholesale services
- (4) Our water supply area is defined in our instrument of appointment and comprises three discrete regions in the south east of England shown on the map below. Charges for the supply of water vary according to region and are shown in our schedule of charges. In our Central Region, there are four sub-regions for rateable value charges: Colne Valley, Lee Valley, Rickmansworth and North Surrey which reflect historical company boundaries.

2. Assurance Statement

The Board of Affinity Water Limited, acting by its Audit Committee, having made due enquiry of management and having considered reports from internal and external assurance providers confirms, to the best of its knowledge, that:

- (a) the company complies with its legal obligations relating to the indicative Wholesale Charges 2019/20 it has published;
- (b) the Board has assessed the effects of the indicative new charges on water supply licensees (as a whole or in groups) who are retailing wholesale services and (assuming such indicative charges are passed through by water supply licensees to their customers) on customers occupying Eligible Premises (as a whole or in groups) and confirms there are no instances where indicative bill increases for licensees (as a whole or in groups) who are retailing wholesale services and (assuming such charges are passed through by water supply licensees to their customers) on customers occupying Eligible Premises (as a whole or in groups) exceed 5%;
- (c) the company has appropriate systems and processes in place (including up-to-date models and data) to make sure that the information published about its indicative Wholesale Charges 2019/20 is accurate; and
- (d) the company has consulted with relevant stakeholders in a timely and effective manner on its indicative Wholesale Charges 2019/20.
