#### Introduction

- (1) The purpose of publication is to provide a transparent indication of primary wholesale charges to existing and prospective retailers to support effective markets.
- (2) The Schedules of Indicative Primary Wholesale Charges for 2025/26 are set out in the following pages of this document. The presentation of our charges tables are aligned with the recommendations of the RWG industry group on tariff simplification.
- (3) Wholesale charges form the basis of charges to retailers for wholesale services.
- (4) Our projections assume that the CPIH inflation rate will be 3.5%. We have projected indicative charges using our current best forecast of billed consumption for 2025/26 and other charging parameters, but may revise this for final charges setting work at the end of the year, in the light of new evidence that may become available.
- (5) Our water supply area is defined in our instrument of appointment and comprises three discrete regions in the south east of England shown on the map below. Charges for the supply of water vary according to region and are shown in our schedule of charges.





#### **Assurance Statement**

The Board of Affinity Water Limited, having made due enquiry of management and having considered reports from external assurance providers confirms, to the best of its knowledge, that:

- (a) the company complies with its legal obligations relating to the indicative Wholesale Charges 2025/26 it has published;
- (b) the Board has assessed the effects of the indicative new charges on water supply licensees (as a whole or in groups) who are retailing wholesale services and (assuming such indicative charges are passed through by water supply licensees to their customers) on customers occupying Eligible Premises (as a whole or in groups) and approves the impact assessments and handling strategies developed in instances where bill increases for licensees (as a whole or in groups) who are retailing wholesale services to eligible customers and on customers occupying Eligible Premises (as a whole or in groups) exceed 5%;
- (c) the company has appropriate systems and processes in place (including up-to-date models and data) to make sure that the information published about its indicative Wholesale Charges 2025/26 is accurate; and
- (d) the company has consulted with relevant stakeholders in a timely and effective manner on its indicative Wholesale Charges 2025/26.

## **Tariff Simplification Plans**

From April 2025, as part of our tariff simplification plans and aligning with Market guidance, we will look to make the following changes.

- Tariff WTMPWAWCM001A in our central region will be retired and the associated SPIDs moved to tariff WTMPWAWCM001, as the rates have aligned.
- Tariff WTMPWAWEM001 in our East region, the last of our tiered tariffs, will become a linear tariff.
- All SPIDs on the above tariff will have their annual consumption reviewed and, based on their consumption, may be moved to ensure they are on the correct tariff.
- Tariff WTMPWAWEM0015TO25A in our East region will be retired and their SPIDs moved to new tariffs based on their annual consumption.
- Tariff WTMPWAWEM003 in our East region will be retired and the associated SPIDs moved to tariff WTMPWAWEM002, as the rates and SPID charges have aligned.
- Tariffs WTMPWAWEM003A in our East region will be retired, as it has not been utilised for many years.
- Tariff WTMPWAWSEM001MA in our South East region will be retired and the associated SPIDs moved to tariff WTMPWAWSEM001, as the rates have aligned.
- With the exception of Special Agreements and Aggregated Sites, all SPIDs are subject to tariff changes based on their annual consumption, as part of the RWG Retail Price Control Groups Guidance.
